Lubrication Best Practice Auditing



Auditing of your lubrication strategies and processes is a popular way to analyse any of the short comings that may yield savings and improvements to reliability and performance.

Audits that are typically conducted are often highly time taxing taking several days or weeks to complete. The SnapShot Audit takes a look at all key lubrication aspects to gain an overview of the lubrication strategy maturity; not every single lubrication point within your facility.




A SnapShot Audit involves interviews with key people, extensive photography, and an extensive walk around of your facility looking at 9 key aspects of lubrication best practice. These include:

-  Lubricant selection & inventory
-  Lubricant deliveries
-  Lubricant storage
-  Lubricant identification & tagging
-  Lubricant transfer
-  Contamination control
-  Lubricant sampling & analysis
-  Greasing
-  Lubricant program management

Each of the 9 sections contains a question set where % scoring is applied. This enables graphing of the results in the final report. Future audits can then be correlated against previous audits to show improvements.
